

## ASSUMPTION OF RESPONSIBILITY AND LIABILITY WAIVER

### Purpose

To ensure the safety and wellbeing of all participants at FAMUN 2022, each participant must sign and submit the liability waiver before joining the conference. The liability waiver is mandatory – without it, participants will not be able to attend FAMUN 2022. The liability waiver must be signed and attached to the registration system until **26 August 2022**.

**Attention:** For High School Delegates, the parent or guardian must read and sign the liability waiver along with the participant. For Brazilians attending the in-person format, the signature of the parent or guardian must be “reconhecida em cartório”. High School delegates will not be allowed to attend the conference without a liability waiver properly signed by the parent or guardian.

<sup>1</sup> In-person format - mandatory protocol against COVID-19: Participants that register for the in-person format must abide by the following protocols against COVID-19: To present a vaccination certificate (3 doses); To wear a mask PFF2/N95/KN95 all the time during all FAMUN 2022 activities and in all FACAMP premises; To keep a physical distance of at least 1 meter, avoiding agglomerations; Not showing up and/or staying on FACAMP premises in case of any adverse symptoms. Immediately notify the FAMUN organization in case of symptoms. Failure to comply with any of the protocols above will result in the suspension of the participant of the FAMUN 2022 in-person conference.
